*SIDNEY MUNICIPAL COURT PROBATION DEPARTMENT*  
*RULES AND REQUIREMENTS FOR PARTICIPATION IN BASIC SUPERVISION*

1. \_\_\_Participant shall not violate any federal, state and local laws.
2. \_\_\_Participant shall comply with all orders set forth by the court.
3. \_\_\_Participant shall work regularly at a lawful occupation and support his legal dependants to the best of his ability. When the participant is out of work they shall notify the court immediately.
4. \_\_\_Participant shall not possess or have under his/her control any firearms at anytime. Nor shall the Participant have under his control or possession any deadly or dangerous ordinance as defined in Section 2923.11 of the Ohio Revised Code.
5. \_\_\_Participant shall not patronize any business or establishment where alcoholic beverages are sold for the consumption on the premises.
6. \_\_\_Participant shall not operate a motor vehicle unless legally licensed to do so.
7. \_\_\_Participant shall not possess, use, sell or distribute or have under his control any narcotic, Barbiturates, and or controlled substance set forth by Sections 3719.10, 3719.23, 3719.41 of the Ohio Revised Code, or extracts containing prescription of a licensed physician. Participant shall not at anytime to be found in the state of intoxication or under the influence of drugs and or alcohol. Participant will submit to random drug testing as requested by the Probation Department or any other law enforcement agency while in said program. A fee of \$5.00 per test shall be paid by the Participant at the time the random drug test is performed. Participant is subject to routine or random checks as needed, anywhere the participant may be. (Home, work, school etc...)
8. \_\_\_Participant shall make regular payments as set forth by the court on all restitution, costs, and fines.
9. \_\_\_Participant shall report to the Sidney Municipal Court Probation Department as ordered. If no date and time are designated, it is the responsibility of each individual participant to contact the court in regards to reporting in. Non-compliance such as failure to report to the Probation Department as scheduled will be subject to sanctioning of Community service and or a Warrant for the defendants arrest.
10. \_\_\_If the offender misses a scheduled appointment it is their responsibility to contact the probation department no later than the scheduled day of the appointment. At that time a determination will be made by the Probation Department staff as to the missed appointment being excused or unexcused. If it is unexcused, community service will be a sanction of 8 hours per scheduled appointment.
11. \_\_\_Appropriate attire is required while visiting the Probation Department. Shoes and shirts must be worn at all times.
12. \_\_\_Offenders placed on the Electronic Monitoring System will be responsible for the daily cost of the program. Payments shall be made one week in advance.
13. \_\_\_No violence of any kind will be tolerated at anytime.

14. \_\_\_Respect will be shown at all times to the staff of the Court and other offenders that may be present.  
Staff members will be addressed by their proper name. No nicknames of any kind will be tolerated.

I, \_\_\_\_\_ have read and initialed the above conditions. I understand these conditions fully and have asked any questions that I may have concerning them. I also understand that a violation of any of these conditions could result in the following:

1. *Immediate removal from the in lieu of programs and returned directly to jail without a hearing to Serve the original jail sentence set forth.*
2. *A warrant issued for my arrest*
3. *Additional Charges could be applied*
