An "Oversize Vehicle Permit" is required to operate or move a vehicle or combination of vehicles on any highway or street within the City of Sidney corporation limits of a size, weight or load exceeding the maximum specified in ORC 5577.01 through 5577.09, or otherwise not in conformity with ORC 4513.01 through 4513.37. No fees are required for the completion of this application.

Please refer to the City of Sidney Codified Ordinances, Chapter 339, Commercial and Heavy Vehicles, for regulations pertaining to loads and other pertinent issues. Section 339.01(c) specifically denotes regulations within City jurisdictions, including weight limits, permission required, and penalties.

Attached is a copy of the City of Sidney Pavement Strength for Overload Permits Map, indicating preferred truck routes within the City of Sidney.

As a permit holder, you are required to follow the "high strength" (green) routes whenever possible. If necessary, use of the "medium strength" routes (yellow) can be used to travel to the general site. Use of "low strength" roads (red) shall be kept to a minimum and notification to the City Street Department prior to travel over these roads is required by calling 498-8142.

Carriers are still liable for roadway or infrastructure damage on any City-owned street due to overweight and oversized loads.

The proposed route of travel will be evaluated along with the length, width, height and weight of the oversized vehicle to determine if safe passage is possible. This evaluation will be completed by the City Street Department with reference to specific pavement construction, base and load bearing capacity.

Upon submittal of a completed Oversize Vehicle Permit Application, the City of Sidney Street Department will log in the request. The applicant will typically receive notification from that office within 5-7 working days regarding the status of the requested permit. If approved, a copy of the permit will be signed by the Street Superintendent or his/her designee and a copy will be given to the City Police Department for their records.

A copy of an approved Oversize Vehicle Permit will be given to the permit applicant, who must carry it with him/her or in the vehicle while moving the load. The vehicle must follow the route designated on the permit, as well as meet all information noted on the permit. This includes, but is not limited to vehicle width, length, height and weight. Unless otherwise noted and approved as such, each permit will be designated for a specific tractor, trailer, load and date. Oversize Vehicle Permits are not transferable. Incorrect data or non-adherence to the route will void the permit.

Any damage to City streets or rights-of-way while moving an oversized load will be assessed to the business organization to which this permit is assigned. The City Street Department and/or Police Department will assess the cost of damage and forward this information to the applicant or agent.

Bonding will be required if the vehicle is not using rated or approved roadways within the City corporation limits. In addition, the name and contact of the business' insurance carrier, along with a recent copy of their insurance document will be required prior to any approvals to move an oversized load.
