



2014 ANNUAL REPORT (O.R.C. 1901.14A4)

As I continue my first full term in office, I would like to thank the citizens of Shelby County for the support and trust bestowed upon me and my staff. I am looking forward to bringing several exciting new projects to completion.

The start of 2014 had my staff working tirelessly to complete configuration of the newly purchased Case Management System. However, by June, these plans were unexpectedly dealt a fatal blow when the contracted vendor suddenly closed it's doors, fired all of it's employees, and defaulted on all contracts Worldwide.

As a result, the Shared Resources Project (SRP) found itself back at square one, forced to re-bid the entire project. Fortunately, the request for proposal was already prepared and needed only to be revised slightly. The successful vendor was selected and contract negotiations are currently being concluded. The Courts have filed a claim in the Federal Bankruptcy Court against the now defunct corporation in an attempt to recover the monies previously paid out on the contract.

On-line credit card payments for the Traffic/Criminal division continue to grow in popularity. In 2014, the Court received \$304,212.14 in on-line credit card payments. This represents an average of over \$25,000 per month, and accounts for approximately one-third of the total revenue received by the Traffic/Criminal Division.

During 2014, 408 individuals entered the License Intervention Program. The Court had a 57% successful completion rate which resulted in another 234 valid properly insured drivers on the roads.

In 2014, \$2,038,684.96 was collected in receipts. In addition \$37,388.66 was provided by offenders to the City and County through the Court's Community Service Program. This program allows those who qualify to account for their fines and costs even when they do not earn sufficient income to pay what they owe by performing community service to local organizations and non-profit agencies.

The Court distributed \$27,892.21 in restitution to victims of crime and distributed garnishment monies in the amount of \$871,282.79 to various creditors.

The Probation Department performed 287 drug tests, conducted 241 pre-sentence investigations and had 1,573 active probationers in 2014. The Bailiff's served 961 papers, transported 1,019 prisoners and the Court held video arraignment for 78 prisoners. More than 33,000 jail days were served by defendants. In place of jail 279 people were placed in counseling and treatment programs such as alcohol and drug, anger management and parenting classes. The Home Arrest program had 475 days served by 11 defendants and saved over \$23,700 in incarceration costs.

The Justice and Mental Health program, also known as the JMHCP program, screened 16 people, admitted 13 to the program, and had 8 successful completions in 2014. This program also became fully funded by the Municipal Court's Special Projects fund in 2014. The Special Projects fund is created by the Ohio Revised Code and is entirely funded through the collection of court costs. The JMHCP program also assisted in providing clothing, groceries, and transportation to appointments, helped with job searches, gave assistance with housing, medication needs, and provided an advocate to outside medical providers.





SIDNEY MUNICIPAL COURT 2014 CASE BREAKDOWN BY AGENCY




