## LANDLORD INFORMATION

By City Ordinance, and as provided for in Ohio law, property owners are responsible for the payment of charges for water and sewer services provided to their property. If the property owner elects to have their tenants pay the water/sewer bill, the property owner is not relieved from the payment of any bills or charges that occur. (ORD 911.13).

Property owners have the option to have their tenants billed on a monthly basis, which requires that a tenant to pay a deposit when signing up for service. All outstanding final bill utility charges will be deducted from the deposit. In addition, the Revenue Collection Department will make a reasonable effort to collect all final bills before charging a tenant's final bill to the property owner.
