**GENERAL INSTRUCTIONS**

1. A permit is required for all work and openings within the right-of-way including curb cuts and driveways.
2. A \$10 permit fee is charged for curb cuts and driveways.
3. A set of plans showing work to be performed must accompany permit, if requested.
4. Work must commence within ten (10) days after permit is issued and be completed by expiration date shown on permit.
5. Disturbed sidewalks must be installed/repared per City Engineering Standards within 30 days of completion of the project.
6. A \$50 fee plus material and labor cost for the repair will be charged for applicant failing to properly repair a street cut to City standards.
