Ohio EPA's notification of demolition and renovation form is required for:

- Every demolition of a facility, regardless of whether asbestos is involved. This includes all structures that will be intentionally burned for fire training purposes.
- A renovation when the amount of regulated asbestos-containing material (RACM) stripped, removed, dislodged, cut, drilled, or similarly distributed exceeds 260 linear feet on pipes or 160 square feet on other facility components or 35 cubic feet facility components.
