## Conditions

Permits is only needed if fishing  
In City parks during closing hours  
Of 10:00 p.m. to 6:00 a.m. or posted  
Closing hours for Tawawa Park

## Needed at the following City Parks:

Bridge  
Custenborder Fields  
Tawawa Park Lakes  
Tawawa Softball Complex  
Roadside Park  
Berger Park  
Johnston Drive Park

## Apply:

At the City of Sidney Parks and  
Recreation Department, Service  
Center, 415 S. Vandemark Rd.  
During normal working hours-8 a.m. to  
4:30 p.m. Monday-Friday. Advise calling  
to make arrangements if applying at the Parks  
Department at 937-498-8155 to assure someone is  
Available to issue permit.  
or at the City of Sidney  
Police Department, Municipal Building.

## Requirements:

Must be 16 years of age and  
have a valid Ohio Fishing License.

If driving a vehicle into the park, a  
Valid driver's license is needed and a  
vehicle parking permit issued by the  
City of Sidney.

## Display Permits:

The vehicle permit must be  
displayed so it is easily viewed-  
i.e. hung on rear-view mirror or  
placed on dashboard. The permit  
holder must also clip on the personal  
Permit so that it is easily seen.

**Children under 16 may  
accompany the permit holder.  
However, he or she must be  
engaged exclusively in fishing  
activities.**
